



3. Operation

Plasticine indicator board is to be installed in the recess in the runway of long and triple jumps, on the side of the white take-off board closer to the landing area. If a jumper damages the plasticine stripe closer to the white take-off board, the indicator is removed from the recess, turned by 180° and reinstalled again. The deformed plasticine stripes of the indicator board are filled up and formed with the forming knife K9-250 (available separately).

4. Storage

During idle periods the product should be stored in a dry room providing relative humidity below 80% and temperature over 5°C.

5. Maintenance

Any defects in paint coating revealed during regular inspections of the product must be repaired with ecological wood paint.
