

Base pads assemble on the pole value of combining them with belts "velcro".

Base pads are designed for pole values STT-65, STT15-65 and STT15-65F.

V. Maintenance

Due to the hygiene requirements it is recommended that the cover should be cleaned regularly with commonly available detergents. Before you start wiping it, please try to clean a small spot on its bottom side in order to check the reaction with the PVC fabric.

VI. Storing

You must not put any tables, chairs, benches or any other objects on the pads. The elements cannot be bent or pressed by any objects during storing. That may deform the pads permanently. A storing facility should be clean and dry. It ought to provide min. temperature 5° C.
